Innovations in Curriculum, Instruction & Assessment

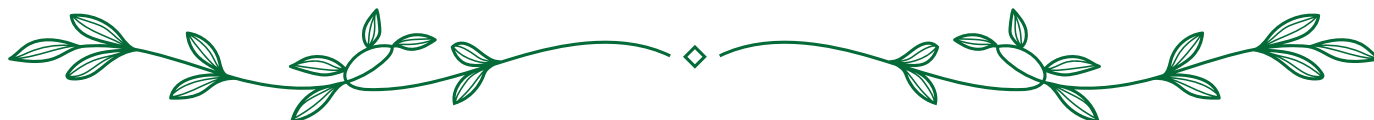
April 14, 2027 | Grappone Conference Center
